
Program Overview

West Coast University's hybrid Doctor of Pharmacy program combines on-campus experiential learning with online instruction to offer our students an accelerated path to earning a PharmD that takes less than three years to complete. The hybrid nature of the WCU PharmD program offers students unique flexibility, resulting in time and cost savings. During their time on campus, students learn through immersive experiences in our simulation labs where they can practice their clinical skills and build their confidence in the safety of a risk-free environment. The curriculum integrates Introductory Pharmacy Practice Experiences (IPPEs) and Advanced Pharmacy Practice Experiences (APPEs) in a continuum of actual pharmacy practice contexts to develop and gradually build on students' critical thinking skills and clinical abilities. Students also choose two elective rotations in pharmacy practice settings aligned with their career interests.

The Accreditation Council for Pharmacy Education (ACPE) accredits Doctor of Pharmacy programs offered by Colleges and Schools of Pharmacy in the United States and selected non-US sites. For a Doctor of Pharmacy program offered by a new College or School of Pharmacy, ACPE accreditation generally involves three steps; Precandidate status, Candidate status and Accredited status. Precandidate status denotes a developmental program that is expected to mature in accord with stated plans and within a defined time period. Precandidate status is awarded to a new program of a College or School of Pharmacy that has not yet enrolled students in the professional program and authorizes the School to admit its first class. Candidate status is awarded to a Doctor of Pharmacy program that has students enrolled but has not yet had a graduating class. Accredited status is awarded to a program that has met all ACPE standards for accreditation and has graduated its first class. Graduates of a class designated as having Candidate status have the same rights and privileges of those graduates from a fully accredited program. ACPE conveys its decisions to the various boards of pharmacy and makes recommendations in accord with its decisions. It should be noted, however, that decisions concerning eligibility for licensure by examination or reciprocity reside with the respective state boards of pharmacy in accordance with their state statues and administrative rules. The Doctor of Pharmacy program of the West Coast School of Pharmacy was awarded Accredited status during the June 20-24, 2018, meeting of the ACPE Board of Directors based upon an on-site evaluation conducted April 3-5, 2018, and discussion with University and School officials. PLEASE NOTE THAT LICENSURE TO PRACTICE AS A PHARMACIST IS REQUIRED IN EVERY STATE. HOWEVER, THE EXAM AND LICENSURE REQUIREMENTS VARY BY STATE. IT IS YOUR RESPONSIBILITY TO RESEARCH THE REQUIREMENTS IN THE STATE IN WHICH YOU PLAN TO PRACTICE.
