



STATE UPDATE

Governor has SIGNED Several Significant Bills

CALIFORNIA COLLEGE PROMISE

AB 19 (Santiago)

Contingent on an appropriation by the state legislature, a district may waive fees for all full time students in their first academic year, regardless of financial need. Details about the bill itself:

- Waives fees for one academic year for first-time students who are enrolled in 12 or more semester units and who complete and submit either a Free Application for Federal Student Aid (FAFSA) or a California Dream Act application.
- Begins in the 2018-19 year. It is not clear whether this would kick-in during the summer 2018 or just the fall 2018.
- No funding mechanism has yet been identified for AB 19, although it is anticipated that the governor will include funding in the proposed state budget for 2018-19, with the first year cost estimated at \$35 million.

Status: Signed October 13

EQUITABLE ACCESS TO HIGHER EDUCATION

AB 21 (Kalra)

Sets statewide policies and guidelines on how colleges and universities can interact with federal immigration officials.

- Requires colleges to refrain from cooperating with immigration officials consistent with state and federal law.
 - Prohibits the disclosure of personal information of faculty and staff unless under specified circumstances such as for academic or programmatic purposes.
- Comply with a request for an immigration official to visit non-public areas on campus upon the receipt of a judicial warrant.
- Provides exceptions to the prohibition from cooperating with immigration officials in regards to international students or employment status verification.

Status: Signed October 5

CALIFORNIA



MATRICULATION: ASSESSMENT

AB 705 (Irwin)

- Requires colleges to utilize evidenced based multiple measures when considering placing students in college level math or English classes.
- Provides that when high transcript data is difficult to obtain that colleges may utilize self reported high school data or guided placement.
- Prohibits community colleges from placing a student in remediation that increases their time to degree unless placement research demonstrates that student is highly unlikely to succeed in transfer level courses.

Status: Signed October 13
