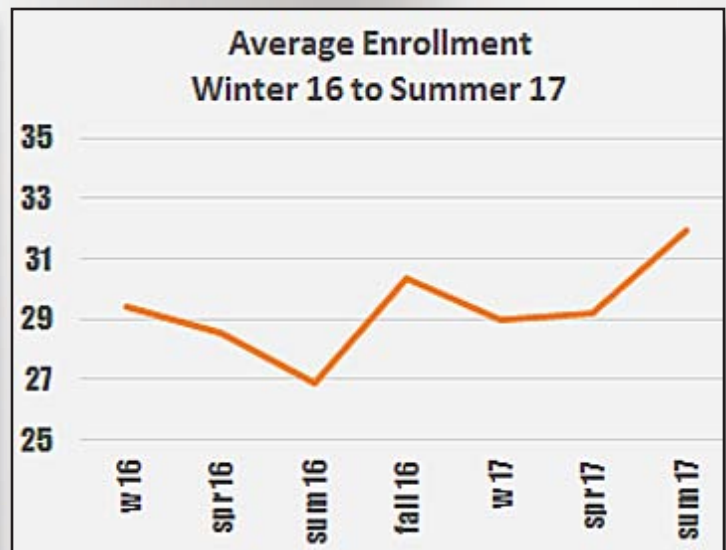
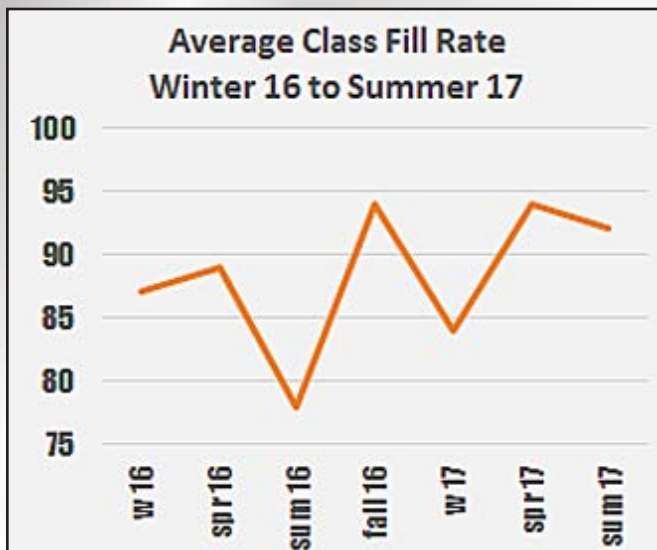

ACADEMIC SERVICES

- Projected to meet or exceed our FTES Goal of 6,865
- More than 700 unique courses & over 1900 sections offered.



ACADEMIC SERVICES - CURRICULUM

- Faculty continue to create or update the Associates in Arts for Transfer and Associates in Science for Transfer.
 - **IVC has 9 AA-Ts and 6 AS-Ts**
 - Must be approved by the Chancellor's Office
 - Completing students transfer all 60 units to a CSU, optimally into the third year toward a bachelors.
- In addition, IVC offers
 - 30 'local' degrees 30 (not AA-T or AS-T)
 - 40 Certificates
 - 10 Apprenticeships

ACADEMIC SERVICES - FAST TRACK

- **Strong Workforce Program** was recommended by the California Community College Board of Governors and then the Governor and Legislature approved funding for the program.
- **Overarching Goal** "More and Better Career Technical Education to Increase Social Mobility and Fuel Regional Economies with Skilled Workers"
- **IVC created two "Fast-Track" Pathways**
 - Welding
 - Prerequisites for Nursing

ACADEMIC SERVICES - WELDING FAST TRACK

- 2 years of welding curriculum compressed into 11 months
- Fast paced and from 8 am to 3 pm
- 22 will be placed into this all-day pathway
- Night sections will continue for all other students
- Completers:
 - Receive IVC Certificate
 - Will be qualified to take 7 of the American Welding Society specialized certificates, which make the student very desirable for industry partners.

ACADEMIC SERVICES - NURSING FAST TRACK PREREQUISITES

- Sequenced and compressed prerequisites into 1.5 years
- Initially 24 will be placed into pathway - IVC and high school students.
- Some will be placed into pathway later based on their unique differences
- Completers:
 - Will apply to RN program in fall 2018 while completing degree requirements
 - If accepted and successful, will complete their RN requirements in fall 2020 & might be able to complete their BSN in 1 year via articulation agreements

- 41 students move forward to Level 2 in Fall 2017 and hopefully to Level 1 in Spring 2018

- 25 students move forward National Exam for Licensure



STUDENT SERVICES - FINANCIAL AID

Financial Aid

2016-17

- \$28.7 million in financial aid and fee waivers has been paid year to date with Summer Pell Grants yet to be disbursed
- Over 8200 students have received some type of award

2017-18

- Financial aid packaging process started on May 23, 2017
- Over 3900 students have been packaged
- Awards are pending Spring Satisfactory Academic Progress evaluations

STUDENT SERVICES - UCSD RECEPTION

- The UCSD Reception for Admitted Students from Imperial Valley was held on Wednesday, May 24th at Maranatha in Imperial. Vice Chancellor, Juan C. González congratulated the students.
- 18 IVC Transfer students were admitted to UCSD
- Of the 18 accepted, 11 were awarded the Chancellor's Associates Scholars Grant

STUDENT SERVICES – DISABLED STUDENT PROGRAM AND SERVICES

- On May 24th, DSP&S held their End of Year Celebration.
- 48 DSP&S Students graduated this year and were awarded an Associates Degree or a Certificate of Achievement.
- 20 DSPS students will be transferring to a CSU or UC during Fall 2017.



STUDENT SERVICES – FIRST STEP EVENT MAY 20, 2017

- On Saturday, May 20th, the Student Success & Support Program held its 4th Annual 1st Step Welcome Event.
- A total of 531 attendees participated in the event; 375 attendees were first time college students and 171 were parents.



STUDENT SERVICES – MENTAL HEALTH AWARENESS WALK

- On May 18th, the IVC Health Center in collaboration with Imperial County Behavioral Health Services held its First Annual Mental Health Awareness Walk.
- There were over 100 participants in attendance!



STATE UPDATE

The deadline for all bills to pass their house of origin was June 2. Below is a summary of some key bills being tracked by the League.

● **AB 387 (Thurmond) Minimum Wage: Health Professionals: Interns:**

League Position: Oppose

Action: Failed to Pass the Assembly.

Would have required hospitals and large medical employers to pay students obtaining hours leading to licensure in an allied health profession.

● **AB 705 (Irwin): Multiple Measures:**

League Position: Support if Amended

Action: Passed on to State Senate.

Would require community colleges to utilize high school performance data, if available, in addition to placement tests when determining to place a student in courses.

STATE UPDATE (CONTINUED)

● **AB 1018 (Reyes) Community College: Student Equity Plans: Homeless Students:**

League Position: Support

Action: Passed on to the State Assembly.

Would add homeless students to the categories of students to be addressed in student equity plans.

● **AB 1453 (Gonzalez Fletcher) The College Athlete Protection Act:**

League Position: Oppose Unless Amended

Action: Passed on to the State Senate.

Would establish a commission with the authority to heavily regulate collegiate athletics. It would have the authority to set safety standards for student athletes, establish procedures to improve graduation rates, and investigate cases of sexual assault.

● **AB 1651 (Reyes) Academic Employees: Involuntary Administrative Leave:**

League Position: Oppose Unless Amended

Action: Passed on to the State Senate.

Would require community colleges to disclose why a community college employee has been put on administrative leave unless a college can prove that revealing the information would hurt campus safety or hinder the investigation.

● **SB 15 (Levy) Student Financial Aid: Cal Grant C Awards:**

League Position: Support

Action: Passed on to the State Senate.

Would increase the Cal Grant C award amount from \$542 to \$2,462 for community college students in a career technical education programs.

● **SB 68 (Lara) Nonresident Tuition:**

League Position: Support

Action: Passed on to the State Assembly

Would extend in-state tuition or state financial aid to undocumented students who were brought to California as children and have spent at least two years at a California community college and one year in K-12.

● **SB 769 (Hill) Baccalaureate Degree Pilot Program:**

League Position: Support

Action: Passed on to the State Assembly.

Would extend the sunset of the baccalaureate degree pilot program to 2029 and extend the pilot program to 10 additional colleges as long as the degree program is not offered at either the California State University or University of California.
