- Official report to follow in approximately 6 weeks and verbal discussion on some of the recommended actions.



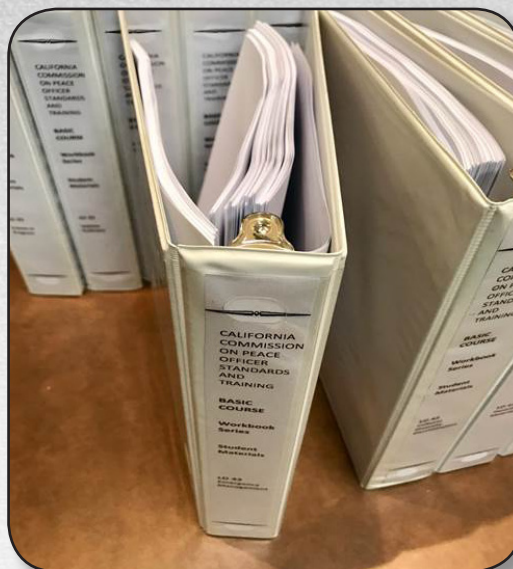
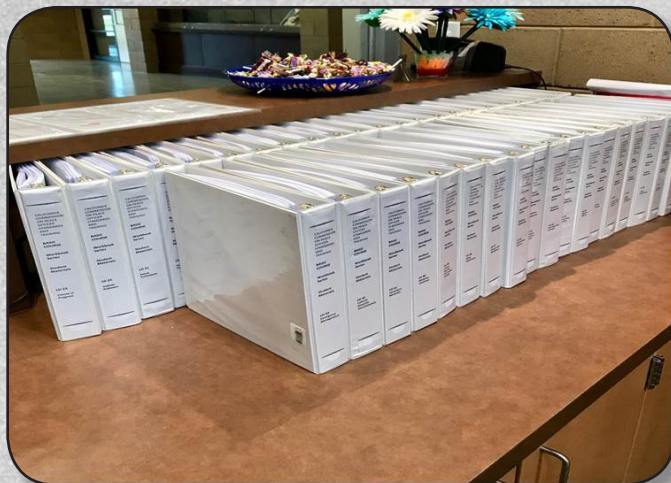

## ACADEMIC SERVICES - STRONG WORKFORCE

- Allocation increased by \$90,000 (from \$658,000 to \$748,000). This was due to exceeding performance matrixes.
- Fast-Track Welding has 44 students – double the number anticipated.
- Fast-Track Nursing Prerequisites has been more challenging, but progressing.
- Imbedded tutors and close monitoring continues.
- Some funds allocated to accommodate additional students in the RN program.

## ACADEMIC SERVICES - STRONG WORKFORCE (CONTINUED)

### INCREASING RN ENROLLMENT

- Admitting 30 students in fall and spring provided funding continues (previously 20).
- Expanded testing lab to accommodate 30 students, allowing more students to observe human simulation.
- Once all computers are installed, entire cohort can be tested at the same time, previously faculty had to split cohorts.
- Relocated Nursing Tutoring Center to allow testing lab expansion.
- Collaborating on 'fast-track' model to prerequisites.
- Some space issues continue for the volume of students admitted.

## STUDENT SERVICES - FINANCIAL AID

- 2017 fall semester: \$9.35 million has been paid out to over 4000 students (including fee waivers). Students are scheduled to receive their final payments on October 27th which is halfway through the semester.
- Financial aid team members will host a training for local high school counselors to provide updates regarding 2018-19 financial aid changes. The training will take place in the financial aid lab on September 29th.

## STATE UPDATE - DACA

By giving Congress six months to forge a replacement for DACA, President Trump has fast tracked a process that earlier this month looked like it would take years. There are currently four initiatives under consideration to codify various elements of DACA into law:

**2017 Dream Act (S. 1615 and H.R. 3440):** Provides protection from deportation proceedings if a person has entered the United States under the age of 18 and have been living in the country since 2012. Provides path to legal permanent residency after five years and citizenship in 10 years. Less restrictive requirements than the recognizing America's Children Act to meet to become either a legal permanent resident or citizen. Some bipartisan support in both the Senate and the House.

**Bridge Act (H.R. 496):** Provides protection from deportation proceedings if a person has entered the United States under the age of 16 and have been living here since 2007. No path to citizenship or legal permanent residency. A person who qualifies must reapply for protection from deportation proceedings every two years. Most similar proposal to DACA. Some bipartisan support in both the Senate and the House.

## STATE UPDATE (CONTINUED) - DACA

**Recognizing America's Children Act (H.R. 1468):** Provides protection from deportation proceedings if a person has entered the United States under the age of 16 and have been living here since 2012. Provides a path to legal permanent residency after five years and citizenship in 10 years. More restrictive requirements than the Dream Act to meet to become either a legal permanent resident or citizen. Some support by House Republicans.

**Hope Act (H.R. 3591):** Provides against deportation proceedings if a person entered the country under the age of 18 prior to 2016. No requirements to be working, enrolled in an education institution or in the military. Provides path to legal permanent residency after three years and citizenship in five years. Strongly supported by House Democrats.

## STATE UPDATE (CONTINUED)

Legislators are closing out the 2017 legislative year this week. After Friday, all bills passed out of the legislature have one month for Governor Brown to sign or veto.

**AB 19 (Santiago) Enrollment Fee Waiver:** Would allow community college districts to waive the enrollment fee for one academic year for certain first-time students. The bill has an anticipated cost of around \$30 million per year. Amendments in the Senate Appropriations Committee made provisions of the bill contingent on future funding appropriation by the state legislature. Status: on Senate Floor

**AB 21 (Kalra) Public Postsecondary Education: Student Success:** Requires colleges to implement specific actions in order to better protect students vulnerable to being deported by immigration officials. Amendments in the Senate Appropriations Committee delay the implementation of the bill to July 1, 2019. Status: on Senate Floor

**AB 204 (Medina) Community Colleges: Student Success And Support Program Funding:** Would require the Board of Governors to review for consistency any due process standards adopted to appeal the loss of a BOG fee waiver. Status: held in the Senate Appropriations Committee and thus dead for this year.

**AB 705 (Irwin) Matriculation: Assessment:** Bill would require California Community Colleges to use high school performance data when determining a student's readiness for college-level English and Math. It also prohibits community colleges from requiring students to enroll in remedial coursework unless research proves that the students are highly unlikely to succeed in college-level coursework. Status: on Senate Floor

## STATE UPDATE (CONTINUED)

**AB 1651 (Reyes) Academic Employees:** Paid Administrative Leave: Would require colleges to provide a copy of the written complaint to alleged perpetrators two days prior to their placement on paid administrative leave. The author took league-supported amendments that create a statewide policy requiring colleges to provide the general nature of the allegations leading to an employee being placed on administrative leave to that employee. Thus the league was able drop its opposition. Status: on Senate Floor.

**SB 169 (Jackson) Education: Sex Equity:** SB 169 would require the governing board of each community college district and other segments of higher education in California to implement policies and procedures on sexual harassment. SB 169 also seeks to conform with some of the guidelines in the "Dear Colleague" letter issued by the United States Department of Education's Office of Civil Rights on April 4, 2011 relating to sexual harassment and sexual violence. Status: on Assembly Floor.

**SB 769 (Hill) Baccalaureate Degree Pilot Program:** SB 769 would extend the sunset on the current California Community College Baccalaureate Degree Pilot Program, from 2023 to 2028. Status: held in the Assembly Appropriations Committee and is thus dead for this year.
